Annual General Meeting May 12, 2021

PRESIDENTS REPORT

Greetings members - I am writing to provide you with the 3rd and final update from NLAOT for the 2020/21 year. Albeit an unusual one, this year has been another great year for Occupational Therapists (OTs) across Canada. Our work continues to be in high demand and [despite the restrictions] our associations and boards have still been able to operate by virtual means. It has had its challenges for sure, but it looks like we've all done a fantastic job in retrospect! I don't think anyone would disagree that the pandemic has helped us all become more comfortable with using technology in the healthcare sector.

Over the next 3 years, we will continue to work in partnership with the Canadian Association of Occupational Therapists (CAOT) and the Alliance of Canadian Occupational Therapy Professional Associations (ACOTPA) to support the National Public OT Awareness Campaign, raising public knowledge about our wonderful profession. In line with other provinces, the NLAOT executive has agreed to contribute funds to the national project for this upcoming calendar year and on a yearly basis as able. This campaign will be highlighting OT's unique role in mental health, long term care, and return to work planning. Phase 1 of the National Public Awareness Campaign is currently complete and the campaign's website (www.oteveryday.ca) will be updated on a regular basis. Currently the campaign is placing ads on Google, Instagram, the Zoomer newsletter, and working towards coverage through CBC, podcasts, blogs, and the Hill Times. I would encourage all members to check out the website and share it with their friends and family in hopes of helping everyone understand our unique and valuable role in the healthcare system.

Although CAOT has an OT mentorship system for Canada, we decided it would be of benefit to build a central mentorship directory for experienced OTs within the province of NL as well.



Since our province has a unique population and faces its own challenges, we feel this would be helpful from both a networking and province-specific perspective. We are pleased to announce that we now have had volunteers come forward for all OT practice sectors for our volunteer mentorship board. Please see our website for the most up to date list and feel free to reach out with any questions. We would like to send a huge thank you to those who came forward. We wouldn't be able to do it without you!

In the coming years as the NL Health Accord finalizes its plan for improving awareness around the social determinants of health and balancing community-based with hospital services, we anticipate that NLAOT will be involved for further collaborative planning. We were invited earlier this year to briefly share about the general role of OT and some of the current practice issues we face and are thankful for the opportunity to have the OT lens incorporated. On the note of collaboration, we also recently met with the Newfoundland & Labrador **Occupational Therapy Board (NLOTB)** to look at areas of similar interest and

opportunities for partnership in the coming years. Similarly to other provinces, we are hoping to meet with NLOTB on a yearly basis to discuss educational opportunities, resources, and position statements on any trending topics (e.g., managing conflict of interest, reporting fitness to drive, psychotherapy language use, documentation, consent, & issues around scope of practice), exploring any opportunities for collaboration.

We are also pleased to announce that the first issue of the OT preceptorship member newsletter is now complete and will be uploaded to our website before the AGM. We would like to send a huge thank you to those OTs (and students) who made a submission, sharing their passion for preceptorship. We are also sending our appreciations to Patti Moores for all of her work with making these placements happen in our wonderful province of Newfoundland & Labrador!

Earlier in 2020, we reached out to members with a poll around who we should nominate from NL for the CAOT citation award, which aims to recognize a community organization that has made significant contribution



to rehabilitation, community health, self-help groups, or provincial initiatives in health care. Our members voted for the The Gathering Place in St. John's and we would like to take a moment to congratulate them on being one of the selected recipients for the CAOT Citation Award. Thank vou to the wonderful staff and leaders at the Gathering Place for everything you do for the community. You deserve the recognition! Finally, I would like to take a moment to say thank you to all our members for all your hard work and contributions this year. If you are interested in being a volunteer executive member, please come out to our annual general meeting in May. Have a great summer!

CAOT BOARD DIRECTOR (NL) REPORT

The CAOT AGM was held on March 22, 2021, virtually via Zoom. Congratulations to Margie Collingwood, one of our NLAOT members, who was re-elected as the Treasurer for the CAOT Board of Directors for a two-year term.

Due to Covid travel restrictions the CAOT Board of Directors continues to meet virtually. The CAOT Board of Directors last met in April 2021, and



will meet again on June 17th and 18th, 2021. Updates from that meeting will be provided, and NLAOT members are encouraged to read CAOT news and updates, including board meeting highlights, in the CAOT weekly email. One of the topics discussed at the April 2021 meeting was the National Occupational Therapy Certification Exam (NOTCE). The NOTCE will be offered again in July 2021, using a hybrid approach without restrictions, allowing candidates to choose inperson testing centres or live remote proctoring.

The annual CAOT conference for 2021 will be a virtual event, from May 16-19th, 2021. The conference was attended by several members last year virtually, who found it to be an excellent opportunity for professional development. Some of the sessions this year highlight topics that are very relevant to practice during the pandemic, including sessions about telepractice. Professional Issue Forums (PIFs) this year include Sexuality from an Occupational Perspective and Palliative and End-Of-Life Care: Making Space for Uncomfortable Conversations. The full conference program can be found here. Registration is available until
